Special Year End Bill Paying Meeting December 28, 2015

Supervisor Gardner opened the meeting at 6pm and led the Pledge of Allegiance.

Supervisor Gardner asked for a moment of silence for: Mark Wrisleys father, Stephen Sayward Sr., Fred Watrous and Jerry Morrows mother.

A motion by James LaForest to take off the table the discussion on the Octogan Schoolhouse. Supervisor asked James Graves if he had looked at the NYS Constitution Article VIII, Section 1. He replied that he had. Supervisor Gardner gave him a copy of the letter from our insurer and one from the legal department of the NYS Association of Towns. So the issue is that the town cannot let anyone use any building without a contract that would include a user fee because it would otherwise be considered a gift. The other issue is that whoever uses the building must have insurance even if the town does. This puts the user first in any lawsuit and protects the town. After further discussion all agreed that the building should not be used until upgrades of power and the interior be made and that James' group should continue investigating options for this to happen. Two other options were suggested for James to consider, one being the old church in Whallonsburgh owned by the Hurlburts and second the Visitors Center owned by ECHO.

James LaForest brought up the possible training opportunities that the county is offering. Supervisor Gardner said that he would get that out to all committee chairs.

A letter was read from H Nicholas Muller III, resigning from the Planning Board effective December 31, 2015 leaving a two year term. Motion made by James LaForest and seconded by Claire LaPine to accept his resignation. All in favor, no nays.

A discussion concerning our lack of a policy for computer, internet and email use it was decided to accept the general policy our insurer gave the town. A more in-depth policy will be compiled by a Policy Committee.

Supervisor Gardner received a proposal from Cedarwood Engineering Services, PLLC for landfill post closure monitoring and reporting. This is a significant reduction than what we pay Adirondack Landfill Services, LLC. Supervisor Gardner stated that our contract with Adirondack is expiring in February. It was decided to put out to bid this service to give Adirondack a chance to adjust their prices.

The issue of the lamp post on the Mastrovich property was brought up. The planning board had asked the board to act on it. Supervisor Gardner stated that after some investigation, the decision of putting the post in the right of way is a matter for the highway superintendent. Also in the zoning law there are some exemptions which include sidewalks, post, shrubs etc. The town board is responsible of the enforcement of decisions made by the planning board and the superintendent. Therefore the board has decided that no action by them can be made and it needs to go back to planning and the highway superintendent.
