## TOWN OF ESSEX Regular Board Meeting August 11, 2016 6:00 pm

Supervisor Gardner called the meeting to order and led with the pledge.

Gretel asked if the Peddlers Policy is old business. It was explained that this is just a policy, that it was submitted as a policy so that it can be fined tuned. There can be no fees attached to a policy because of enforcement. Gretel asked about the no parking on Main Street with the exception of the three events. So if someone wants to put a food truck for in their driveway for a party, is that ok because they are being hired by one person. That is a private function not related to vendor. A vendor sells to the public. But if they are placed on a state highway, they also need DOT approval. Bryan asked about enforcement. This is just a policy and the Code Officer can ask them for their permit but the only enforcement we have is to revoke their permit. Claire asked about #10 on the restrictions. It was clarified that as long as it was not impeding the operation of the business or an inconvenience to the public, it was ok. Everyone agreed that this was a good start.

James LaForest made and Bryan Garvey seconded a motion to accept the Peddling and Soliciting Policy.

Supervisor Gardner referred to the letter that each board member received from the Belden Noble Memorial Library board stating that they had received a grant from the NYS Education Department to renovate and repair the building. The board submitted a proposal for the handicapped ramp and are requesting the approval of the town board to go ahead with it.

Gretel Schueller made and Claire LaPine seconded a motion to approve the work with the stipulation that proof of insurance be submitted to the town from the contractor. All in favor, no nays.

Supervisor Gardner explained that a budget adjustment is needed because we budgeted the CHIPS on what we received last year. This year we were awarded more money. The addition to the budget is the difference, which we should receive from them before the year ends.

It does not matter that the water department has tanks and a building there already. Anything new has to be approved first.

Supervisor Gardner stated that we are advertising for 2 alternates for the planning board. He has talked with Harold MacDougal who is interested. We have advertised this on our web page and bulletin boards.

A discussion on the AES billing including the bills they have from Hydrosource. It was asked if the town can get a more itemized bill for hours, like a lawyer gives. Ed told the board he will be scheduling a water source meeting in a few weeks and will ask for this.
