RESOLUTION # 55– 2018

WHEREAS, street lights are an integral public service provided by municipalities, and are vital for the safety of homeowners, businesses, institutions, pedestrians, motorists and first responders; and

WHEREAS, street light costs consume a significant amount of energy, and represent a significant portion of municipal electricity bills; and

WHEREAS, it is the policy of the State of New York to encourage shared services among municipalities for cost saving opportunities; and

WHEREAS, advancements in lighting technology have made it possible for municipalities to realize energy savings after converting to Light Emitting Diode (LED), street lights; and

WHEREAS, municipalities interested in converting to LED street lights can either purchase the system from the utility (company), or convert through the utility (company) program; and

WHEREAS, municipalities who opt to convert through the utility (company) owned pathway have the responsibility to select the LED wattages and color temperatures they would like to install (within a range of predefined options as offered by the utility), as well as whether they would like to add or eliminate lighting; and

WHEREAS, municipalities may opt to conduct a street light inventory and design study to ensure that the conversion best meets the needs of the community, reduces the cost of operation, and increases safety; and

WHEREAS, the design process includes many soft costs that can be prohibitive for smaller municipalities and which may be reduced through an aggregation of the design work; and

WHEREAS, the Town of Plattsburgh, with the support of the Adirondack North Country Association (ANCA), will serve as the lead municipality allowing multiple municipalities to "piggyback" on a contract with a street light design contractor.
