Supervisor brought forward again the sale of the Old Stone Church. He asked all board members if they received the letter from the town attorney. According to the attorney the most important issue is the encroachment and you cannot sell the property without this finalized in a deed. He suggested we use the resolution in place to sell to the Daltons who currently own the property where the encroachment occurs. Councilperson Schueller objected saying that the town should spend the money needed to hire a land attorney not associated with the town and another appraiser so as to get more from the sale. Councilperson LaForest felt that we should move forward with the sale and that this has been many years in the making and it needs to be done. Councilperson Garvey said he would have liked to see it sold by bid but agreed that with the restrictions we should sell to the Daltons. A motion was made by James LaForest to move forward with the sale of the church as per Resolution 86-2015 to sell to the Daltons for \$90,000.00. Bryan Garvey seconded the motion.

Supervisor Gardner told all that there is a rumor going around about the Old Dock. He said the town has received a request from Jack Halpin for an application for a permit for demolition and another for building a home for the Old Dock. Supervisor Gardner said he has been in contact with the Essex County IDA and they will look into seeing if Mr. Halpin wants to sell or lease the property. Discussion ensued as to whether it's a historical property and can it be demolished. Planning will be the ones to determine this if it proceeds.

Supervisor Gardner also reported that the final well has been tested. Preliminary reports are good. Pumping for 72 hours it was stable for 30 gallons per minute. With a combination of well 1 and three we should have the required amount. Well 2 only produced 6 gallons per minute but well 2 is in the 15-20 gallon per minute range. HE also stated that there will still be filtration in the new plant to filter lake water if needed, especially in an emergency.

The Town Clerk asked for the minutes of the May 4th, Joint meeting with Willsboro be approved. Gretel made the motion and James seconded it. All in favor no nays.

Supervisor Gardner asked if anyone had questions concerning any of the reports. Councilperson Schueller commended Tina Gardner, Water Superintendent and Wastewater Operator for the excellent reports. She noted that Tina is making every effort to save money.

With no other business before the board, a motion by James LaForest to adjourn the meeting at 7:30.
