Supervisor Gardner opened the meeting with the pledge.

Roll Call: Supervisor Gardner, Councilpersons; LaForest, LaPine, Garvey and Wrisley.

Also in attendance: Tina Gardner, Lou Comeau, Bradley French, Jane Terlouw, Bonnie Monoski, Gretel Schueller, Tom Stranski

Supervisor Gardner offered the floor to Lou Comeau. Lou wanted to thank the board for their continued support with the Community Garden. He said it was a successful year and hoped next year to have more participants. He also thought our garden was much nicer than the one in Willsboro and it is also very convenient for those in the hamlet. Supervisor Gardner stated that throughout the summer we had many visitors to the town come in and comment how nice the garden was. He and the board thanked Lou for all his hard work.

Mark asked if he was looking to have them repainted because they are there. Supervisor Gardner stated that the state would have to do it and he would contact them.

Resolution 97-2015 was accepted after changing of the wording from permanent to seasonal banning. There was concerns on how this came about. It started in the summer when the town received complaints that moorings were being dropped to close to others. After consulting with the NYS DEC it was discovered that our mooring laws are incorrect. Each mooring must have a permit from the DEC. In order for the DEC to enforce any illegal moorings, the town must place signage prohibiting personal property on the beach. Concerns were discussed about no access to the beach and permits that have been paid for. It was decided to make it a seasonal ban for now.

Resolution 97-2015 is being offered to allow the town to place an ad and signage concerning the town beach as follows:

The Town of Essex prohibits any personal property to be left on the town beach, in Whallons Bay, including but not limited to boats, dinghies and moorings between November 1st and May 1st. Anything left after November 1st will be removed by the town. To claim your property, you must submit proof of ownership and pay a recovery fee of \$100.

Resolution 98-2015 - Final Order Establishing Town-Wide EMS District November 12, 2015

WHEREAS, the Essex Town Board wishes to form a Town-wide EMS District in accordance with Article 12-A of the New York Town Law for the purpose of providing emergency medical and ambulance services within the town; and

WHEREAS, the Town Board adopted a Resolution authorizing the preparation of a map, plan and report for the purpose of analyzing the formation of the District;

WHEREAS, a Map, Plan and Report was prepared concerning the proposed District and was filed in the Town Clerk's Office and made available for public inspection; and

WHEREAS, the Map, Plan and Report describes the boundaries of the proposed District, the proposed method of operation, the maximum amount proposed for the ambulance services and the cost of the proposed District to the typical property and, if different, the typical one or two family home; and

WHEREAS, on July 9, 2015, subsequent to the filing of the Map, Plan and Report with the Town Clerk, the Town Board adopted an Order reciting (a) the boundaries of the proposed District being the Town's border; (b) the proposed services and proposed method of operation; (c) the maximum amount proposed to be expended for the services; (d) the cost of the District to the typical property and the typical one or two family home (if not typical); (e) that no capital improvements are anticipated for the proposed District, services and capital improvement is on file in the Town Clerk's Office; and (g) the time and place of a public hearing on the proposed District; and

WHEREAS, copies of the Public Hearing Order were duly published and posted were filed with the Office of the State Comptroller, all as required by law; and

WHEREAS, prior to publication of the Public Hearing Order, a detailed explanation of how the estimated costs of the District to the typical property and typical property and typical one or two family home (if not typical property) were computed was filed with the Town Clerk for public inspection as part of the Map, Plan and Report; and

WHEREAS, a Public hearing on the proposed EMS District was duly held on August 6, 2015 and the Town Board has considered the evidence given together with other information; and

WHEREAS, on July 9, 2015th Town Board adopted a Resolution determining that providing of the services described in the Map, Plan and Report will not have a significant adverse impact on the environment and authorizing the filing of the completed SEQRA Short Form EAF as a SEQA Negative Declaration – Notice of Determination of Non-Significance regarding the action;

WHEREAS, on July 9, 2015 The Town Board ADOPTED A Resolution determining that (a) the notice of Public Hearing was published and posted as required by law and was otherwise sufficient; (b) all of the property and property owners within the proposed District would be benefited thereby, (c) all of the property and property owners benefited are included within the boundaries of the proposed District and (d) the establishment of the District as therein described is in the public interest and approving the establishment of the District as the boundaries are set forth in the Map, Plan and Report subject to permissive referendum in the manner provided in Town Law Article 7; and

WHEREAS, the Town Board exercised its authority to make the formation of the EMS District subject to public referendum; and

WHEREAS, such referendum as held on Tuesday, November 3, 2015 and the EMS District formation was approved by the Town's voters; and

WHEREAS, the permission of the State Comptroller is not required pursuant to Town Law Section 209-f;

NOW, THEREFORE, IT IS HERBY ORDERED, that the Town of Essex Town-wide EMS District be established as described in the Map, Plan and Report and the services described in the Map, Plan and Report be provided upon the required funds being made available for; and it is

FURTHER ORDERED, that the Essex Town Clerk is hereby authorized and directed to cause a certified copy of this order to be duly recorded in the office of the County Clerk in the time and manner required by law; and it is

FURTHERE ORDERED, the Essex Town Clerk is hereby authorized and directed to cause a certified copy of this Order to be filed in the office of the State Department of Audit and Control in the time and manner required by law.
