Regular Board Meeting October 8, 2015

Supervisor Gardner responded that no decisions have been made. He will be doing research for appraisals and auctioning to the board so they can make the decision at a later date.

The town clerk reported that a special painting was brought to her to ask the board to accept on put it in a place of honor. The painting was done by Sid Couchey, given to Patti James. It was hanging in the Willsboro Senior Housing and they gave it to Norma Goff. She asked Dale Boardman to make a frame for it. The board unanimously agreed to accept and put it in a place of honor. It was suggested by Jim LaForest to get an engraved plate to explain the depiction.

Supervisor Gardner again told the board that he would get all the information to them that will be needed to make a decision on the Old Stone Church.

Supervisor Gardner told the board that water was hit on Beggs Point at approximately 450 feet with over 4 gallons a minute. Then sometime after the drillers left water started pouring out. The water has been tested and there are no organics. More complete tests are being done. We are looking into possibly fracturing the well to see if we can enlarge the water source. At this point unsure how many gallons per minute this will produce.

Contract between the Town of Essex & Willsboro – Essex EMS For Operating the Ambulances

The Town of Essex will receive the Ambulance presently owned by the Essex Fire District #1. The Town of Essex will keep that ambulances and register and insure it with the Town of Willsboro in the two ambulance districts. The two Ambulance Districts will maintain the Chassis of all ambulances. The Town of Essex will proportionately (based on total assessed valuation) fund a reserve fund to replace the ambulances as required, after they reach 20 years of age or when conditions require. The Towns and Willsboro – Essex EMS will negotiate the number of ambulances required for the two Towns. Willsboro – Essex EMS will operate the ambulances provided by the two Towns and provide EMS service in the two Towns. Willsboro – Essex EMS will participate in the Essex County Mutual Aid system and assist nearby Towns as required and receive mutual aid from nearby Towns as required. Willsboro – Essex EMS will maintain the equipment in the Ambulance as required by NY Department of Health, Mountain Lakes EMS and our Medical Director. Willsboro – Essex EMS will fund an equipment reserve account for those purposes.

For Funding

The Town of Essex has formed an Ambulance District (subject to Voter approval in November) and has budgeted \$59,460 for 2016 to fund Willsboro – Essex EMS. This, along with the Town of Willsboro's share of \$140,540, will fund the budget request of \$133,000 and establish a Reserve Fund of \$67,000 for future needs of Willsboro – Essex EMS.

The yearly budget for Willsboro – Essex EMS will be negotiated on a yearly basis, and it will be paid for proportionately - based on total assessment - by the two Towns. The Two Towns will decide what they think is appropriate to add to the Reserve Fund each year.
