RESOLUTION INTRODUCING PROPOSED LOCAL LAW NO. 1 OF 2017 ENTITLED "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-C"

The following resolution was offered by James LaForest, who moved its adoption.

Upon the passage of a motion to consider from the floor, and the same appearing proper and necessary. **BE IT RESOLVED** that the Town of Essex Town Board hereby introduces proposed Local Law No. 1 of 2017 entitled "A Local Law to Override the Tax Levy Limit Established in General Municipal Law §3-c," reading and provided as follows:

[&]quot;TOWN OF ESSEX LOCAL LAW No. 1 OF 2017"

A Local Law to Override the Tax Levy Limit Established in General Municipal Law §3-c.

BE IT ENACTED, by the Town of Essex Town Board as follows:

Section 1. Legislative Intent.

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Essex pursuant to General Municipal Law §3-c, and to allow the Town of Essex to adopt a budget for the fiscal year 2018 that requires a real property tax levy in excess of "tax levy limit" as defined by General Municipal Law §3-c.

Section 2. Authority.

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.

Section 3. Tax Levy Limit Override - Budget Authorization.

The Town Board of the Town of Essex hereby overrides the tax levy limit for the Town of Essex for 2018 and authorizes the Town of Essex, after completing all required procedures for the adoption of a budget, to adopt a budget for 2018 that requires a tax levy that is greater than the tax levy limit calculated for 2017 pursuant to §3-c of the General Municipal Law.

Section 4. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgement shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, form or corporation, or circumstance, directly involved in the controversy in which such judgement or order shall be rendered.

Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.

BE IT FURTHER RESOLVED that the Town Board of the Town of Essex shall hold and conduct a public hearing on the foregoing proposed local law on the 12th day of October 2017, at 6:15 p.m., to hear any and all persons concerning the same; and

BE IT FURTHER RESOLVED that the Clerk of the Town of Essex will publish a notice of such hearing in the designated Town newspaper at least five days prior to said hearing.
